Asire ke ou konsève moso lèt sa pou sa kontinye tcheke estati ka w la. *Tanpri kenbe nan tèt ou ke li se yon bagay nòmal pou tan plizyè mwa ant randevou.*

### Enstriksyon pou tcheke estati ka w la nan telefòn:

1. Rele 1-800-375-5283
2. Pouse 1 pou kontinye nan lang Anglè; **Press 2 for Spanish**
3. Pouse 1 pou sèvis imigrasyon
4. Pouse 1 pou tcheke estati yon aplikasyon
5. Pouse 1 si ou konnen nimewo resi ou
6. Antre nimewo ka w ki gen 13 karaktè (anjeneral li kòmanse ak NBC\*)
7. Pouse 1 pou konfime nimewo a out e antre nan
8. Koute estati aktyèl la nan ka w la.

### Enstriksyon pou tcheke estati ka w la so entènèt:

1. Gade resi ou oswa frè avi apwobasyon egzansyon ou. Nan kwen an gòch anwo, pral gen yon “Nimewo Aplikasyon” oswa “Nimewo Resi.” Li anjeneral kòmanse ak “NBC” oswa “IOE.” Se nimewo sa ou pral sèvi pou gade estati ka w la sou entènèt.
2. Ale nan [www.uscis.gov](http://www.uscis.gov) epi klike sou “Tcheke Dènye Nouvèl Ka Ou” nan direksyon mitan paj la. Wè imaj ki anba a (maké).
