

## **USCIS FOIA Request**

- The Freedom of Information Act ("FOIA") allows the public to request access to records from certain federal agencies.
- A USCIS FOIA request allows clients to view copies of their immigration records (a.k.a. their "alien" or "A File") or another person's immigration records.
- FOIA requests are useful for discovering unknown information about clients' immigration histories that is needed to complete their applications or to provide the best legal advice.
- To submit a FOIA request you will need the subject of record's:
  - o current name, name at the time of entry into the U.S.; and any other names used;
  - A-Number;
  - o parents' and other family members' names that may appear in the A File;
  - date and country of birth;
  - mailing address and contact information;
  - o signature or electronic consent (see below).
- It is helpful, but not necessary, to include the subject of record's: Form I-94 arrival-departure record number; passport or other travel document number; USCIS online account number; and prior application or petition receipt number(s).
- FOIA requests can be submitted online or by email, fax, or mail.
- To submit a request online:
  - o go to <a href="https://first.uscis.gov/">https://first.uscis.gov/</a> and create an MyUSCIS account;
  - o enter the required information about the request and subject of record; and
  - enter the subject of record's email address or cell phone number so that he or she may provide verification of identity and consent; or

- o upload a signed Form G-639; or
- upload a signed Form G-28 and separate letter containing the subject of record's full name, current address, date of birth, place of birth, and A number, with a notarized signature or signed under penalty of perjury.
- As of March, 2020, an online request may also be submitted using a different system at: https://www.dhs.gov/dhs-foia-privacy-act-request-submission-form.
- To submit a request by email, fax, or mail, you should complete Form G-639 and send it to:
  - uscis.foia@uscis.dhs.gov;

  - U.S. Citizenship and Immigration Services National Records Center (NRC) FOIA /PA Office P.O. Box 648010 Lee's Summit, MO 64064-8010
  - Requests submitted by email, fax, or mail may have longer processing times than those submitted online.
- After you submit the request you will receive a tracking number. Eventually, the results will
  be available online or sent by mail depending on how you submitted the request.
- USCIS may charge a processing fee of up to \$25 for the request.
