LETTER FROM THE EXECUTIVE DIRECTOR & BOARD CHAIR

As Project Citizenship celebrates its 10-year anniversary, it's a privilege to provide this Impact Report highlighting our efforts, activities, and successes during 2023.

Project Citizenship assisted more than 1,000 clients in filing citizenship applications in 2023, in spite of a mid-year pause as the organization underwent a leadership and staff transition. Though we serve all eligible permanent residents, we focus on the most vulnerable and disadvantaged populations: in 2023, low-income clients represented 70% of cases, and those with disabilities, 15%. Our application approval rate remained consistently above the national average.

A highlight every year, Boston Citizenship Day, a mega citizenship workshop in partnership with the Boston Mayor's Office for Immigrant Advancement, once again was a tremendous success. Hundreds of pre-screened clients worked 1:1 with pro bono attorneys to complete the 20-page citizenship application. Other volunteers captured our clients' immigrant stories, which reflect the resourcefulness, resilience, and sense of hope that new citizens-to-be bring to our community.

In 2023, we also held citizenship workshops in Brockton, Lowell, Lawrence, and Cambridge, drawing on partner organizations with deep ties in these communities to ensure we reached those most in need of our services. We continued to offer virtual workshops as well, a model that provides flexibility to immigrants who cannot attend our in-person events.

What made our success in 2023 possible? The continued and growing importance of our mission along with our expert and dedicated staff, devoted community partners, loyal volunteers and Board, and generous donors. Thank you! As we begin our second decade advocating for immigrant rights and promoting a more inclusive society, we know the need for citizenship services is only going to grow. Now more than ever, the work of Project Citizenship is essential to empower individuals, make us stronger, and strengthen our democracy.






CITIZENSHIP DAY

Citizenship Day in Boston is our largest annual event where eligible immigrants receive assistance on their citizenship application. Since launching Boston Citizenship Day in 2014, nearly 3,000 individuals have started on their citizenship journey through this event. On average, we have served applicants from over 50 countries in the single day event, and we have completed over 1,200 fee waivers, providing financial support for low-income applicants. Thanks to the help of volunteer attorneys, law students, and community members we have been able to keep this tradition.

VOLUNTEER IMPACT

Project Citizenship annually enlists and trains over 1,000 volunteers who engage in one-on-one sessions with clients, guiding them through the 20-page citizenship application. Pro bono attorneys meticulously review each application to ensure accuracy and compliance. Our team then does a final review before submitting the application as the attorney of record. This structured oversight allows our organization to amplify our capacity to serve more clients with a lean staff while maintaining the integrity of the submission process. Volunteers are the backbone of our organization, providing essential support up to the final review stage.






